

CITY OF COCKRELL HILL, TEXAS
ORDINANCE 2005 - P

AN ORDINANCE OF THE COCKRELL HILL CITY COUNCIL PROVIDING FOR THE LEVY AND COLLECTION OF AN AD VALOREM TAX ON PROPERTY SITUATED WITHIN THE CORPORATE LIMITS OF THE CITY OF COCKRELL HILL, TEXAS, FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT FOR THE FISCAL YEAR OF 2005-2006, AND PROVIDING A LEVY FOR ITS SPECIFIC PURPOSE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COCKRELL HILL, TEXAS:

I.

THAT there is hereby levied and shall be collected as provided by law an ad valorem tax for the tax year 2005 (City budget fiscal year 2005-2006) on all property, real and personal or mixed, situated within the corporate limits of the City of Cockrell Hill, Dallas County, Texas, and that the rate to be applied to the value of all such property subject to taxation shall be \$0.761590 cents per \$100 of assessed valuation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$28.

II.

THAT a portion of the tax so levied and assessed and a part of the rate thereof shall be apportioned to the following uses and funds in the amount set forth:

Maintenance & Operations General Fund \$0.761590 (per \$100 valuation)

III.

THAT the Mayor is authorized to execute contract renewals for the continued collection of taxes by the Dallas County Appraisal District and the law firm of Linebarger, Heard, Goggan, Blair, Graham, Pena & Sampson, LLP.


IV.

THAT taxes provided for herein are levied and appropriated according to the terms of all applicable state statutes. Should any part of this ordinance be declared invalid for any reason, that invalidity shall not affect the remainder of this ordinance, which remainder shall continue in full force and effect.


V.
